All requirements for the ELDT and TPR must be complied with by February 7, 2022 per the Final Rule from the FMCSA on January 29, 2020. The delay will give the State Driver Licensing Agencies and the FMCSA adequate time to integrate the electronic transfer of information. We believe the requirements for the ELDT will not change as to what has previously been published.

- The date for training providers to upload ELDT training certification information into the registry is postponed until 2022
- The date for State Driver Licensing Agencies to receive driver-specific ELDT data is postponed until 2022
